2	27101929	Other diesel oils and fuel oils not elsewhere specified or included	Manufacture from waste oils collected in Macao which are produced from consumption in Macao. The principal processes are filtration, dehydration, distillation and cooling.
3	33011100	Essential oils of bergamot	Manufacture from natural ingredients. The principal processes are extraction (lixiviation, separation), purification or concentration.
4	33011200	Essential oils of orange	Manufacture from natural ingredients. The principal processes are extraction (lixiviation, separation), purification or concentration.
5	33011300	Essential oils of lemon	Manufacture from natural ingredients. The principal processes are extraction (lixiviation, separation), purification or concentration.
6	33011400	Essential oils of lime	Manufacture from natural ingredients. The principal processes are extraction (lixiviation, separation), purification or concentration.
7	33011900	Essential oils of other citrus fruit	Manufacture from natural ingredients. The principal processes are extraction (lixiviation, separation), purification or concentration.
